(3) Date and Time for submitting Application Form for Admission to Primary One:

*Please do not duplicate your application. (Submitting a printed copy and applying on the e-Platform).

If parent/ guardian submits the application form **in person**, please prepare the following documents:

1. The original copy of Parent's/ Guardian's (the person who signed the application form) ID Card, Passport or other identity documents.

(if parent/ guardian authorizes another person to submit the application form, the authorized person must present a photocopy of the parent's /guardian's identity document and an authorization letter. The template of the letter can be downloaded from the website of the Education Bureau.)

2. A completed Application Form for Admission to Primary One. (with two duplicate copies).

3. The original copy and a photocopy of the applicant child's birth certificate.

→ If the child's 'Status of permanent resident in HKSAR is 'Not Established', the original copy and a photocopy of his/her travel document(s) or Permit to Remain in Hong Kong must be presented.

 \rightarrow in the absence of a Hong Kong Birth Certificate, the parent/guardian should bring along the original copy of the applicant child's Birth Certificate (non-local) and document(s) permitting him/her to stay in Hong Kong and their photocopies.

4. If the parent/ guardian claims the applicant child's sibling is studying at our school, the following documents have to be presented:

(1) the original copy and a photocopy of the Birth Certificate of the applicant child's sibling;

(2) the original copy of the sibling's school handbook (2023-2024) and a photocopy of the page listing the sibling's personal details.

5. If the parent/ guardian claims the applicant child's sibling/ parent is a graduate of our school, the following documents have to be presented:

(1) the original copy and a photocopy of the Birth Certificate of the applicant child's sibling;

(2) the <u>original copy</u> and <u>a photocopy</u> the graduate certificate of the applicant child's sibling/ parent.

6. The original copy and a photocopy of the proof of residential address

 \rightarrow the recipient's name of the proof document must be the same as that the applicant's (the parent's/guardian's);

 \rightarrow the proof includes (but isn't limited to) stamped tenancy agreement, demand note for rates, public housing tenancy agreement or water/ electricity/ town gas/ residential telephone bills;

 \rightarrow please note that the address on a bank letter, court summon, and tax bill are not accepted by the Education Bureau;

 \rightarrow if the applicant child's residential address submitted is that of his/ her grandparent(s), the <u>original copy</u> and <u>a photocopy</u> Birth Certificate of the applicant child's parent has to be presented as the proof stating the declared relationship.
